THIS AMENDMENT OF AMENDMENT 1 TO PUBLIC PRIVATE PARTNERSHIP AGREEMENT is made as of 25 November 2015, by and between:

(1) **THE REPUBLIC OF KOSOVO**, acting by and through its Public-Private-Partnership Committee, duly represented herein by Avdullah Hoti, Chairman of PPP Committee, hereinafter referred to as the "Grantor";

and

(2) **LIMAK KOSOVO INTERNATIONAL J.S.C.**, a joint-stock company organized and existing under the laws of the Republic of Kosovo, with registered office address: Mujo Ulqinaku, Prishtina, Kosovo duly represented herein by Haldun Kokturk, Managing Director of LKIA hereinafter referred to as the "Private Partner"

WHEREAS,

- A. On August 12, 2010, the Grantor and the Private Partner executed the Public Private Partnership Contract ("hereinafter referred to as the "PPP Agreement") for the PPP for the operation and expansion of the Prishtina International Airport "Adem Jashari";
- B. The Grantor and Private Partner have agreed and duly signed the Amendment 1 on September 17, 2015.
- C. The Grantor and Private Partner have agreed to make certain amendments in the article 4 of the Amendment 1.

IT IS THEREFORE AGREED AS FOLLOWS:

1. DEFINITIONS

The terms and definitions used in this amendment shall have the meaning as defined in the PPP Agreement, unless otherwise defined in the present Amendment, or, if the context, within which the term is used, requires a different interpretation.

2. ACKNOWLEDGMENT AND WAIVERS

2.1 Both Parties do hereby acknowledge and agree that article paragraph 3 of the Article 4 of the Amendment no. 1 of 17 September, 2015 to the PPP Agreement of 12 August, 2010 shall be deleted.



3. ENTIRE AMENDMENT

This Amendment shall replace the specific article as described herein and shall constitute an integral part of the entire Agreement.

4. EFFECTIVE DATE OF THE AMENDMENT

This Amendment is effective as of 25 November 2015. All other terms and conditions remain as in the original documents of the PPP Agreement except those which are consistent with this Amendment.
